Chairman Miles opens the regular meeting at 7:00 pm

Chairman Miles excuses Paul DiPietro from the meeting.

Chairman Miles asked members if they had read the minutes of the June 3, 2024 meeting and if anyone had additions or corrections, and hearing none, ask for a motion to approve.

#### AGENDA ITEM – 305 WALL ST SITE PLAN REVIEW

William Maloney will recuse himself from the meeting while discussing the Site Plan as it is a conflict of interest with the applicant. It is noted that Mr. Maloney is seated with the applicant and not with the board for this discussion.

Chairman Miles refers to the site plan and states that this has already been in front of the Zoning Board of Appeals and that an Area Variance was granted. Mark invites the applicant, Stacey Carollo, whom resides at 305 Wall Street, to address the board to explain what she would like to do. Ms. Carollo states she would like to demolish an existing deteriorating garage and would like to add a one-story addition for her aging mother. Mark thanks her and then asks if there are any board members that have questions for Stacey Carollo. A board member asks if the addition will

be attached to the house to which she responds "It would be connected to the house via a breezeway". Attorney Moore remarks that the Planning Board is reviewing the amended application, which was done so at the ZBA meeting to reduce the requested setback from 15ft to 18ft. Eric Crandall explains that the current existing garage has an 18-foot setback and the new addition will maintain that setback.

Chairman Miles asks if anyone else has questions – hearing none – he asks Attorney Moore what the next options are. Attorney Moore states that the board can review the site plan and set up a public hearing or review the plan and waive the public hearing and accept as final plan.

Chairman Miles reminds the board of section 217-49 (Waiver Requirements) which states as a whole, "The Planning Board is authorized to waive any requirements of this article, including a public hearing, in the event any such requirement is found not to be necessary in the interest of the health, safety, and general welfare."

Chairman Miles seeks to have a motion to approve or deny the site plan.

**MOTION** is made by Nick Kapnolas to approve the site plan for Stacey Carollo to replace existing garage with a home addition.

Seconded by Robert Knapp

Attorney Moore states that a preliminary plan must be accepted first. An amendment is made to the motion that states the board will accept the preliminary site plan.
